

Standard T&Cs for NFU Mutual Canterbury and Sittingbourne Agency Prize Draw Promotions

Terms and Conditions for a meal for 4 at Read's Restaurant for a tasting menu with wine Prize Draw

1. The prize draw is open to all UK residents aged 18 years or over, except employees of NFU Mutual, their families, Agents or any third party directly associated with administration of the prize draw.
