

Standard T&Cs for NFU Mutual Agency Prize Draw Promotions

Terms and Conditions for Locally Sourced Hamper Prize Draw

1. The prize draw is open to all UK residents aged 18 years or over, except employees of NFU Mutual, their families, Agents or any third party directly associated with administration of the prize draw.
2. The prize draw is free to enter and no purchase is necessary.
3. The winner will receive a hamper containing locally sourced produce.
4. All entries must be submitted by posting the answer to our question and tagging in a friend via the NFU Mutual Haywards Heath Facebook page.
5. The closing date of the prize draw is 11.59pm on 03/10/2021. Entries received after this time will not be entered into the draw.
6. The prize is non-exchangeable, non-transferable and there is no cash alternative.
7. NFU Mutual Haywards Heath Agency accepts no responsibility for entries not successfully completed due to a technical fault [technical malfunction, computer hardware or software failure, satellite, network or server failure] of any kind.
8. A winner will be chosen by a random draw on 08/10/2021.
9. The winner will be notified via Facebook (using details provided at entry) by 08/10/2021 and must provide a postal address to claim their prize. If a winner does not respond to NFU Mutual Haywards Heath Agency within 14 days of being notified by NFU Mutual Haywards Heath Agency, then the winner's prize will be forfeited and NFU Mutual Haywards Heath Agency will be entitled to select another winner in accordance with the process described above.
10. The winner will receive their prize within 7 days of being notified of their win.

14. Participants are deemed to have accepted and agreed to be bound by these terms and conditions upon entry. NFU Mutual Haywards Heath Agency reserves the right to refuse entry or refuse to award the prize to anyone in breach of these terms and conditions.
15. NFU Mutual Haywards Heath Agency reserves the right to hold void, cancel, suspend, or amend the promotion where it becomes necessary to do so.
