

## Standard T&Cs for NFU Mutual North Hampshire Agency Prize Draw Promotions

### Terms and Conditions for Newlyn Farm Shop £150 Voucher Prize Draw

5. The closing date of the prize draw is midday on the 31<sup>st</sup> of December 2023. Entries received after this time will not be entered into the draw.

9. The winner will be notified by email or telephone (using details provided at entry) by 31<sup>st</sup> December 2023 and must provide a postal address to claim their prize.
