However, each policy year up to 10% of your investments made can be withdrawn without an early withdrawal charge. This can be carried forward twice if it is not used so that in year three, up to 30% of your investments made can be withdrawn with no charge.

If this/these have been lost, by signing this form you are agreeing that:

- I/we are not aware of anyone else having a financial interest in this investment.
