

Terms and Conditions for Driving Confidence Sessions Prize Draw

- 1. This promotion is open to residents of the UK, the Channel Islands or the Isle of Man aged 18 or over who hold an active NFU Mutual car or Light Goods Vehicle insurance policy and a full valid driving licence, with up-to-date tax and a valid MOT certificate for their vehicle.
