

Standard T&Cs for NFU Mutual Agency Competitions

Terms and Conditions for Mid Devon Show Competition 2026

1. The competition is open to all UK residents aged 18 years or over, except employees of NFU Mutual, their families, Agents or any third party directly associated with administration of the prize draw.
2. The competition is free to enter and no purchase is necessary.
3. The winner will receive a local produce hamper.
4. All entries must be submitted via our Ballot Box on our trade stand and only one entry per person is permitted.
5. The closing date of the competition is 5pm on 26/07/2026. Entries received after this time will not be entered into the competition.
6. The prize is non-exchangeable, non-transferable and there is no cash alternative.
7. NFU Mutual Exeter, Tiverton and South Molton Agency accepts no responsibility for entries not successfully completed due to a technical fault [technical malfunction, computer hardware or software failure, satellite, network or server failure] of any kind.
8. A winner will be chosen at random within the agency on 27/07/2026.
9. The winner will be notified by email or telephone (using details provided at entry) by 28/07/2026 and must provide a postal address to claim their prize. If a winner does not respond to NFU Mutual Exeter, Tiverton and South Molton Agency within 14 days of being notified by NFU Mutual Exeter, Tiverton and South Molton Agency, then the winner's prize will be forfeited and NFU Mutual Exeter, Tiverton and South Molton Agency will be entitled to select another winner in accordance with the process described above.
