

Standard T&Cs for NFU Mutual Agency Competitions

Terms and Conditions for Pin the Inn to Win

1. The competition is open to all UK residents aged 18 years or over, except employees of NFU Mutual, their families, Agents or any third party directly associated with administration of the prize draw.

4. All entries must be submitted via scanning the QR Code and completing and submitting the online form. One entry per household is permitted.
5. The closing date of the competition is 4PM on Sunday 20th September 2026. Entries received after this time will not be entered into the competition.
